# **Terms of Use**

## Welcome to our wireless Internet service

By using the Service, you are agreeing to these Terms & Conditions of Use ("Terms"). Please read them carefully.

## Acceptance of the Terms

By clicking on "I AGREE" on the service sign-up page, you represent that:

- 1. You have read, understand and agree to the Terms
- 2. You are at least 18 years of age

If you do not agree to the Terms, you may not use the Service. Your electronic acceptance of the Terms by clicking on the "I AGREE" on the sign-up page has the same effect as if you had actually signed the Terms. The effective date of these Terms is the date that you click on "I AGREE".

#### **Description of the Service**
